Shares will be eligible for entry in the draw from the month after they are purchased provided that the application form and payment has been received by the 21st of the month. Shares paid for by standing order will become eligible from the month after that in which the first payment is made.
- 4 A member of the club may purchase more than one share.
- 5 The draw will be held on the first Sunday of every month. There will be a single prize of £100 for the holder of the share whose number is drawn. Winners will be notified by post or e-mail.
- 6 The first draw will be held in the month following the month in which applications for shares first exceed 40. The date of the first draw will be advertised on posters in All Saints Church.
- 7 If applications for shares do not reach 40 by 1 August 2009 the 100 Club will be wound up and any subscriptions paid returned in full (but without interest). Should the number of shares in issue fall below 30 after draws have commenced, or if the Trustees of ASK otherwise so decide, the 100 Club will be wound up and the unused portion of any subscription refunded.
